In consideration for allowing me to participate in any way in the event listed above, including its related events and activities, I, the undersigned, understand, acknowledge, appreciate, and knowingly and voluntarily agree that:

1. The dangers and hazards inherently involved in this event pose a risk of injury that is significant and substantial, and includes the risk of serious and permanent bodily injury and death. While particular skills, equipment, and personal discipline may reduce this risk, the risk of serious injury or death exists and is inherent in the activities involved in this event.
